

The Staunton Downtown Trolley serves historic downtown Staunton destinations. | **Operation: Monday-Friday, 10:00AM-9:00PM (Nov-Apr service concludes at 6:00PM); Saturday, 10:00AM-6:00PM**

The Staunton Saturday Night Trolley operates Saturday evenings providing connections to retail and entertainment destinations. | **Operation: Saturday, 6:00PM-10:00PM (Nov-Apr service concludes at 9:00PM)**

The Staunton West/North Loops serve outlying neighborhoods and medical and retail destinations. | **Operation: Monday-Friday, 6:30AM-7:30PM; Saturday, 7:30AM-5:30PM**

The Stuarts Draft Link provides service within Stuarts Draft, and connections with Fishersville and Waynesboro. Stops include retail and residential areas, Augusta Health facilities, and employment centers. | **Operation: Monday-Friday, 6:45AM-6:45PM**

The Waynesboro Circulator travels within the city limits of Waynesboro, providing connections to employment centers, retail, and medical facilities. | **Operation: Monday-Friday, 6:30AM-6:22PM; Saturday, 7:30AM-8:22PM**

The 250 Connector connects to the Staunton routes, the Waynesboro Circulator, the Stuarts Draft Link, and the Blue Ridge Community College (BRCC) Shuttle, and provides service between the cities of Staunton and Waynesboro in the Route 250 corridor, with stops including Augusta Health and WWRC. | **Operation: Monday-Friday, 7:30AM-9:30PM; Saturday 8:30AM-7:30PM**

The Blue Ridge Community College (BRCC) Shuttles route is operated by two buses. One bus begins and terminates at BRCC, and the other bus begins and terminates at the Staunton Hub/Lewis Street. The buses provide service between Staunton and the BRCC Campus in Weyers Cave, and from the campus to Harrisonburg through Bridgewater, Dayton, and Mt. Crawford. | **Operation: Monday-Friday, 7:00AM –7:00PM (Bus 1); 7:30AM-5:30PM (Bus 2).**

All buses are fully ADA accessible. Eligible certified riders are required to make reservations for the **BRITE Access** ADA compliant paratransit or deviated fixed route service on the prior day, and up to two weeks in advance, by calling the customer service phone number.

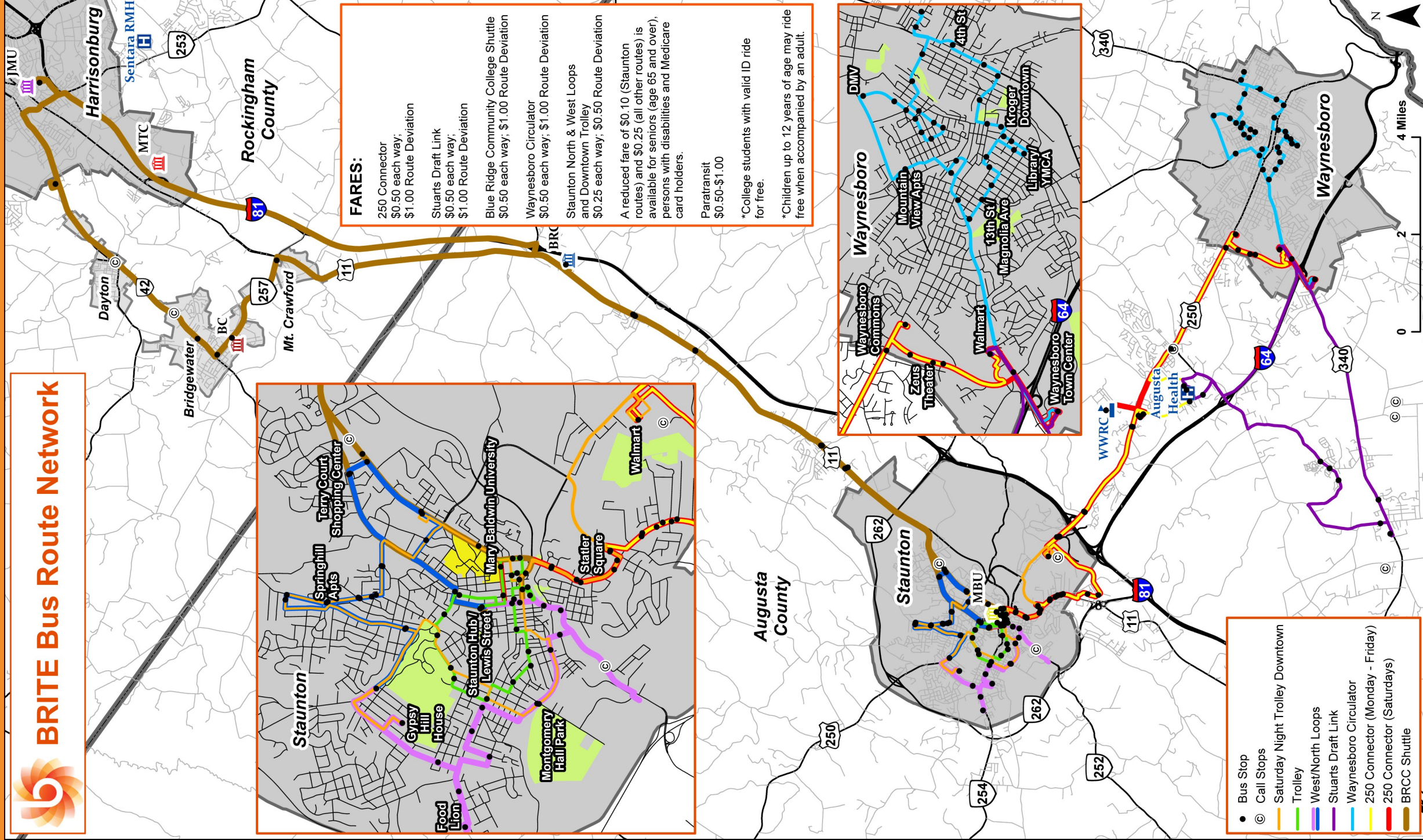
